TO ALL WHOM THESE PRESENTS MAY CONCERN:

We, James R. Henderson and Marian H. Henderson (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY, FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Seven Thousand and No/100- - - - - DOLLARS (\$7000.00), with interest thereon from date at the rate of Five (5%) - - - per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being shown as a part of lot # 3 of Section A of the Buist Land, plat of said property being recorded in the R.M.C. Office for Greenville County, in Plat Book "C" at Page 10, and said lot having the following metes and bounds, to-wit:

"BEGINNING at an iron pin, 200 feet from Rutherford Street on the North side of Mountain View Avenue, and running thence with the Northern side of Mountain View Avenue, S. 65 E. 83.8 feet to the corner of lot # 4; thence with line of said lot, N. 25 E. 164.5 feet to an alley; thence with said alley, N. 65 W. 83.8 feet to iron pin on alley; thence S. 25 W. 164.6 feet to an iron pin on Mountain View Avenue; the point of beginning. Being the same premises conveyed to the mortgagors herein by Arthur C. Easton and Ruby B. Easton by deed to be recorded herewith."
