TO ALL WHOM THESE PRESENTS MAY CONCERN:

J. ED. DAWSON

WHEREAS, I the said J. Ed. Dawson,

in and by my certain promissory note in writing, of even date with these Presents... LIBERTY LIFE INSURANCE COMPANY... Five Thousand & no/100 (\$5,000.00) DOLLARS... date hereof until maturity at the rate of five per annum... Beginning on the 6th day of November, 1948... each month of each year thereafter the sum of \$53.05... day of Sept., 1958... day of October, 1958... each are to be applied first to interest at the rate of five per annum on the principal sum of \$5,000.00... and the balance of each monthly payment shall be applied on account of principal.

All instalments of principal and all interest are payable in lawful money of the United States of America; and in the event default is made in the payment of any instalment or instalments, or any part thereof, as therein provided, the same shall bear simple interest from the date of such default until paid at the rate of seven (7%) per centum per annum.

And if at any time any portion of principal or interest shall be past due and unpaid, or if default be made in respect to that time unpaid together with the accrued interest, shall become immediately due and payable, at the option of the holder thereof, who may sue thereon and foreclose this mortgage; and if said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if, before its maturity, it should be deemed by the holder thereof necessary for the protection of its interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings; then and in either of such cases the mortgagor promises to pay all costs and expenses including a reasonable attorney's fee, these to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW, KNOW ALL MEN, That I, the said J. Ed. Dawson

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said LIBERTY LIFE INSURANCE COMPANY according to the terms of the said note, and also in consideration of the further sum of THREE DOLLARS, to me

the said J. Ed. Dawson in hand well and truly paid by the said LIBERTY LIFE INSURANCE COMPANY, at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said LIBERTY LIFE INSURANCE COMPANY, its Successors and Assigns, forever:

All that lot of land with the improvements thereon situate, lying and being on the North side of Rhett Street in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot 7 on plat of Estate of J. H. Ware made by R. E. Dalton, Engineer, November 1920, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book P, page 264 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Rhett Street at joint front corner of Lots 6 and 7, said pin being 56.5 feet West from the Northwest corner of the intersection of Rhett Street and McCall Street, and running thence along the line of Lot 6, N. 18-49 W. 124.7 feet to an iron pin; thence S. 71-15 W. 56.4 feet to an iron pin in line of Lot 8; thence with the line of Lot 8, S. 18-45 E. 125 feet to an iron pin on the North side of Rhett Street; thence along the North side of Rhett Street, N. 71-00 E. 56.5 feet to the beginning corner.
