NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southeast side of Westview Avenue, near the City of Greenville, being shown and designated as lot No. 19 of Block C, Section 2, on plat of East Highlands Estates, made by Dalton & Neves, Engineers, May 1940, and recorded in the R. M. C. Office for Greenville County in Plat Book K, at page 44, and having, according to said plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Southeast side of Westview Avenue at joint front corner of lots Nos. 18 and 19 of Block C, and running thence with the line of lot No. 18, S. 52-50 E. 160 feet to an iron pin on the Northwest side of a 5-feet strip reserved for utilities; thence with the Northwest side of said strip reserved for utilities N. 39-25 E. 60.05 feet to an iron pin; thence with line of lot No. 20, N. 52-50 W. 162.5 feet to an iron pin on Southeast side of Westview Avenue; thence along the Southeast side of Westview Avenue, S. 37-0 W. 60 feet to the beginning corner."
