Whereas, the said Shives-Hughes Realty Co.

neers, January 1947, recorded in the R. M. C. Office for Greenville
County, S. C., in Plat Book P, page 113, said lot fronting 50 feet
on the East side of West Fairview Avenue and having such other dimen-
sions as shown on the recorded plat mentioned above.
