less than FIVE THOUSAND AND NO/100
satisfactory to the mortgagee from loss or damage by fire, and the sum of FIVE THOUSAND AND NO/100

AND should the Mortgagee, by reason of any such insurance against loss by fire or tomado as aforesaid, receive any sum or sums of money for any damage by fire or tomado to the said building or buildings, such amount may be retained and applied by it toward payment of the amount hereby secured; or the same may be paid over, either wholly or in part, to the said
Mortgagor,successors, heirs or assigns, to enable such parties to repair said buildings or to erect new buildings in their place, or for any other purpose or object satisfactory to the Mortgagee, without affecting the lien of this mortgage for the full amount secured thereby before such damage by fire or tornado, or such payment over, took place.
