WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Western side of Courtland Drive, being known and designated as lot # 20 as shown on a Map of High View Acres prepared by Dalton & Neves, Engineers, February 1945, and being more particularly described according to said plat as follows:

"BEGINNING at an iron pin on the West side of Courtland Drive, joint front corner of lots # 20 and 21, which pin is 905.6 feet North of the Northwestern intersection of Courtland Drive and Sulphur Springs Road, and running thence with joint line of said lots, N. 84-30 W. 650.5 feet to an iron pin; thence N. 6-47 W. 204.7 feet to an iron pin, joint rear corner of lots # 19 and 20; thence with joint line of said lots, S. 84-30 E. 694 feet to an iron pin on the Western side of Courtland Drive; thence with said Drive, S. 5-20 W. 200 feet to the beginning corner. Being the same premises conveyed to the mortgagor by Eva McDonald Timmons by deed to be recorded."

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
