MORTGAGE OF REAL ESTATES SWORTER

To All Whom These Presents May Concern:
I, Coy T. Bruce, of Greenville County SEND GREETING:
WHEREAS, I the said Coy T. Bruce
in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of FOUR THOUSAND, THREE HUNDRED AND NO/100(\$ 4,300.00)  Four (4%)  Dollars, with interest at the rate of six (6%), per centum per annum, to be repaid in instalments of TWENTY-SEVEN AND NO/100 (\$ 27.00 ) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed month-

thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me.,

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Butler Township on the Southeast side of Brookdale avenue, and being known and designated as a portion of Lot No. 10, of Block D, of a subdivision known as Fair Leights, as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book F, at page 257, and having the following metes and bounds, to-wit:
"BEGINNING at an iron pin on the Southeast side of Brookdale avenue at the corner of Lot No. 9, of Block D, which point is 442.5 feet from the intersection of the Laurens Road, and running thence along the line of Lot No. 9, S. 58-40 E. 135 feet to an iron pin at the corner of lot heretofore conveyed to J. W.
