with interest thereon from the date hereof at the rate of **Four** per centum per annum, said interest to be paid on the **1st** day of **November** 19 **48** and thereafter said interest and principal sum to be paid in installments as follows: Beginning on the **1st** day of **December** 19 **48**, and on the **1st** day of each month thereafter the sum of \$ **57.57** to be applied on the interest and principal of said note, said payments to continue up to and including the **1st** day of **October**, 19 **68**, and the balance of said principal sum to be due and payable on the **1st** day of **November**, 19 **68**, the aforesaid monthly payments of \$ **57.57** each are to be applied first to interest at the rate

of **Four** per centum per annum on the principal sum of \$ **9500.00** or so much thereof as shall from time to time remain unpaid and the balance of each monthly payment shall be applied on account of principal.
