To All Whom These Presents May Concern:

I, Ollie Bruce Buice xxxxxxxxxxxxxxxxxxxx SEND GREETING:

WHEREAS, I the said Ollie Bruce Buice

in and by my certain promissory note in writing of even date with these Presents, am well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of

Five Hundred xxxxxxxx xxxxxxxxxxxxxxxxxxxx (\$ 500.00) Dollars,

with interest from the date hereof at the rate of seven per cent (7 %) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of

Eight xxxxxxxx xxxxxxxxxxxxxxxxxxxx (\$ 8.00) dollars

due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest and all costs, insurance, and expenses incurred in connection with said loan, has been paid, said monthly payments to be applied first to the payment of interest, and then to payment of principal, costs, expenses and insurance, if any, incurred; and said note further providing that if at any time any portion of the principal or interest due hereunder shall be past due and unpaid for a period of sixty (60) days, or upon failure to comply with any of the by-laws of said Association, or with any of the stipulations of this mortgage, the whole amount due under said note, shall at the option of the holder become immediately due and payable, and said note further providing for a reasonable attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and collectible as a part thereof, if the same be placed with an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind.

KNOW ALL MEN BY THESE PRESENTS, That I the said

Ollie Bruce Buice, in consideration of the said debt and sums of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING & LOAN ASSOCIATION, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to me the said mortgagor in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, near the old city limits of Greer, lying on the South side of Brown Street (formerly called McAdoo), being all of Lot #51 and a part of Lot #52 on a plat of property of the N. M. Cannon land, said plat recorded in R.M.C. Office for Greenville County in Play Book "P", page 199, and having the following courses and distances, to wit:-

BEGINNING at a pin on the southern edge of Brown Street, 61 feet East from the intersection of Brown Street with Pine Street and being the joint front corner of Lots 50 and 51 and runs thence with the southern edge of Brown Street N 76-45 E 80 feet to a pin on southern edge of said Brown Street; thence S 13-00 E 160 feet to a pin on the northern edge of Spring Street; thence along the northern edge of Spring Street S 76-40 W 80 feet to pin, joint corner of Lots 50 and 51; thence with the common line of Lots 50 and 51 N 13-00 W 160 feet to the beginning corner. This is the same lot of land conveyed to me by J. E. Buice by DEED recorded in Vol 361, page 275 in the R.M.C. Office for Greenville County.
