WHEREAS I . Daisy Gambrell,

well and truly indebted to

Anna M. Beaty, Trustee for Eugene Gallamore,

in the full and just sum of Five hundred no/100 Dollars, in and by my certain promissory note in writing of even date herewith, due and payable in installments of ten dollars per week due and payable on Saturday of each week beginning October 30th, 1948,

with interest from date at the rate of six per centum per annum until paid; interest to be computed and paid quarterly and if unpaid when due to bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Anna M. Beaty, Trustee for Eugene Gallamore,

All that certain lot of land in Greenville Township, Greenville County, State of South Carolina, on the north side of Julian Street, near the City of Greenville, being known as Lot No. 29 on Plat of Sub-division known as Queen Heights made by N. O. McDowell, Jr., and J. P. Moore, November, 1944, recorded in the R. M. C. Office for Greenville County in Plat Book 0, at Page 87, and having the following metes and bounds according to said plat:

BEGINNING at an iron pin on the north side of Julian Street at joint front corner of Lots Nos. 29 and 30, said pin also being 210 feet west from the northwest corner of the intersection of Julian Street and Queen Street, and running thence with the line of Lot No. 30, N. 21-45 E. 116 feet to an iron pin; thence with the rear line of Lot No. 9, N. 68-43 W. 40 feet to an iron pin; thence with the line of Lot No. 28, S. 21-45 W. 115 feet to an iron pin on the north side of Julian Street; thence with the north side of Julian Street, S. 67-39 E. 40 feet to the beginning corner.

The above described lot of land is the same conveyed to me by W. R. Cely and Eleanor C. Carter by deed dated May 15, 1946, and recorded in Book 294, page 358.
