four per centum (4 %) per annum until paid, said principal and interest being payable at the office of The Peoples National Bank of Greenville, South Carolina in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Six and 36/100

Dollars (\$ 6.36), commencing on the first day of

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville, Gantt Township, State of South Carolina; being known and designated as Lot No. 91-A according

to plat of property of Woodfields, Inc., a subdivision located on the southwest side of the Augusta Road, said lot having the following metes and bounds, according to plat made by Dalton & Neves, Engineers, plat recorded in the R. M. C. Office for Greenville County in Plat Book S, Page 113:

Beginning at an iron pin on the northeast side of Brook Forest Drive at the joint front corner of Lots 91 and 91-A and running thence N. 38-20 E. 136.8 feet to an iron pin at the rear corner of Lot 91; thence S. 67-02 E. 87.8 feet to an iron pin at the rear corner of Lot 92; thence along the line of Lot 92 S. 38-20 W. 160 feet to an iron pin on Brook Forest Drive; thence along Brook Forest Drive N. 51-40 W. 160 feet to the beginning corner.
