I, HOWARD S. STEVENSON

Whereas, I the said Howard S. Stevenson

in and by my certain Note or obligation bearing even date herewith, stand indebted unto

The Prudential Insurance Company of America

in the full and just principal sum of Six Thousand and No/100 Dollars (\$6,000.00),

with interest thereon from date hereof, at the rate set forth in the note aforesaid; the principal of said note together with interest being due and payable in monthly instalments as follows:

Beginning on the first day of December, 1948, and on the first day of each month thereafter the sum of Forty-five and 90/100 Dollars and the balance of said principal sum due and payable on the first day of November, 1963. The aforesaid monthly payments of Forty-five and 90/100 Dollars each are to be applied first to interest at the rate as aforesaid on the principal sum of Six Thousand and No/100 Dollars, or so much as shall from time to time remain unpaid, and the balance of each monthly instalment shall be applied on account of principal.

Said note provides that past due principal and interest shall bear interest at the rate of seven percent per annum, as reference being had to said note will more fully appear; default in any payment of either principal or interest to render the whole debt due at the option of the Mortgagee.

All that lot of land with the buildings and improvements thereon, situate, lying and being on the South side of Newman Street, in the City of Greenville, in the County of Greenville, State of South Carolina, being shown as Lot #54 on Plat of McDaniel Heights, made by Dalton & Neves, Engrs., April 1941, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "L", pages 46-47, and having according to said plat and a recent survey made by R. W. Dalton, Surveyor, October 14, 1948 the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Newman Street, at joint front corner of Lots 54 and 55, said pin being 275 feet East from the Southeast corner of the intersection of Newman Street and Belmont Avenue, and running thence along the South side of Newman Street N. 85-50 E. 70 feet to iron pin; thence along the line of Lot 53 S. 4-20 E. 170.5 feet to iron pin; thence S. 85-50 W. 70 feet to iron pin at joint rear corner of Lots 54 and 55; thence along the line of Lot 54 N. 4-20 W. 170.5 feet to iron pin on South side of Newman Street, the beginning corner.
