in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

all that tract or lot of land in Township, Greenville County, State of South Carolina.

All that piece, parcel or tract of land situate, lying and being in the County of Greenville, State of South Carolina, on waters of Enoree River, adjoining lands of W. L. Lafon, S. Bishop, S. S. Crittenden, Isabella Shelton et al and containing forty-two acres, more or less, and having the following metes and bounds, according to a plat made by F. H. Fuller, Surveyor, dated October 18, 1882:

BEGINNING at a stake on the side of the road thence N 12 W 7.70 to a hickory 3X; thence N 60 E 9.00 to a Poplar oak; thence N 20 5/6 E 17.70 to pin 3X near road; thence N 7 2/3 E with said road 18.10 to white oak 3X; thence N 75 1/2 E 3.59 to stake 3X; thence S 16 E 9.37 to Poplar oak 3X; thence S 20 W 2.14 to B oak stump at spring; thence down said branch as a line 18.50 to white oak stump at branch and old road; thence with said road as a line to the beginning corner; this being the same piece of property conveyed to W. E. Hart by George F. Benson by deed dated January 4, 1910, said deed recorded in the R.M.C. Office, Book 5, Page 360 and conveyed to G. F. Benson by Dyer Shelton, Administrator, December 4, 1882, said deed recorded in said office in Book NN at Page 418.

BEGINNING on a stone N.W. corner, thence running S 10 1/2 E 6.54 chs to a stone; thence N 61 1/2 E 19.16 to a stone in old road; thence N 34 W 6.80 to a stone in said road; thence S 44 1/2 W 2.13 to a stone; thence S 67 1/2 W 3.45 to a stone; thence S 62 W 4.80 to a stone O.M.;
