All that certain piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, lying and being more or less north side of National Highway alternate No. 28 near Paris and being a portion of land designated as lot No. 7 of property of B. M. McGee Trust, as shown on plat thereof by Walter H. Hayes, Engineers, Book Case No. 1241, recorded in Plat Book "C", Page 33, R. M. C. Office Greenville County, and having according to said Plat the following description, to-wit:
