To All Whom These Presents May Concern:

We, W. E. Wynn, Jr. and Pearl Timmons Wynn SEND GREETING:

WHEREAS, we the said W. E. Wynn, Jr. and Pearl Timmons Wynn

in and by our certain promissory note, in writing, of even date with these presents are well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of TWO THOUSAND, FIVE HUNDRED AND NO/100 - - - (\$2,500.00)

Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of TWENTY-FIVE AND NO/100 - - - - - (\$ 25.00) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That we, the said W. E. Wynn, Jr. and Pearl Timmons Wynn

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to us,

the said W. E. Wynn, Jr. and Pearl Timmons Wynn in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, located about three and one-half miles North of Greenville, S. C., and being known and designated as Lot No. 42 on plat of subdivision known as Buncombe Park, said plat being recorded in the R. M. C. office for Greenville County, S. C., in Plat Book "M", at page 12, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at a point on the north side of North Haven Drive, joint front corner of Lots Nos. 41 and 42, and running thence along the line of Lot No. 41, N. 3-20 W. 173 feet to a point, joint rear corner of Lots Nos. 41 and 42; thence N. 88-00 E. 60 feet to a point, joint rear corner of Lots Nos. 43 and 42; thence along the line of Lot No. 43, S. 3-20 E. 173 feet to North Haven Drive; thence along North Haven Drive, S. 88-00 W. 60 feet to the beginning corner; being the same conveyed to us by J. W. Hodgens and Sophia T. Hodgens by their deed dated December 31st, 1945, recorded in the R. M. C. office for Greenville County in Deed Vol. 285, page 369."
