All that certain piece, parcel or lot of land situate, lying and being on the South side of Mountain View Avenue, in that area recently annexed to the City of Greenville, in Greenville County, South Carolina, being shown as the Western 90 feet of Lot #7 and the Eastern 10 feet of Lot #6 adjacent thereto, in Block "B" of the subdivision of the Buist Property known as Oakland Heights, plat of which is recorded in Plat Book "F", page 204, said lot fronting 100 feet on the South side of Mountain View Avenue and running back in parallel lines for a depth of 170 feet six inches to the North side of a 19-foot alley.
