on the Northwest side of Grove Road in that area recently annexed to the City of Greenville, in Greenville County, State of South Carolina, being shown as Lot #24, the Southwest one-half of Lot #23 and the Northeast one-half of Lot #25 of Block "A", on plat of Grove Park, made by W. On Sept. 3, 1948 I executed a mortgage on the above property in the amount of \$6900.00 to C.Douglas Wilson & Co. which is of record in the R.M.C.Office for Greenville County in Mortgage Book 399, page 414. In that mortgage the legal description failed to designate this property as being in Block "A" of Grove Park; therefore, this corrected mortgage is executed by me in order to give a complete legal description of the property intended to be covered by the previous mortgage above mentioned.
