"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Town ship, on the East side of Berkley Avenue, being known and designated as Lot No. 33, as shown on Plat of Franklin Heights, recorded in Plat Book M at Page 89, and having, according to said Plat, the following metes and bounds, to-wit:
