, a corporation organized and existing under the laws of the United States, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Seventeen Hundred and no/100

Dollars (\$1,700.00), with interest from date at the rate of four per centum (4 %) per annum until paid, said principal and interest being payable at the office of The Peoples National Bank of Greenville, South Carolina in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Ten and 31/100

Dollars (\$ 10.31), commencing on the first day of January, 19 49, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of December, 19 68.

Beginning at an iron pin on the northern side of Crestfield Road at the joint front corner of Lots 53 and 52 and running thence along the line of Lot 53 N. 38-23 W. 235.5 feet to an iron pin at the rear of Lot 53; thence along the rear line of Lot 37 N. 48-49 E. 70.2 feet to an iron pin at the rear corner of Lot 51; thence along the line of Lot 51 S. 38-23 E. 239.1 feet to an iron pin on Crestfield Road; thence along Crestfield Road S. 51-37 W. 70 feet to the point of beginning.
