AMORTIZATION MORTGAGE

KNOW ALL MEN BY THESE PRESENTS, That T. J. Johnson and Mittie B. Johnson of the County and State aforesaid, hereinafter called first party, whether one or more, SEND GREETINGS:

WHEREAS, first party is indebted to The Federal Land Bank of Columbia, a corporation created, organized and existing under and by virtue of an Act of Congress, entitled the Federal Farm Loan Act, hereinafter called second party, as evidenced by a certain promissory note, of even date herewith, for the principal sum of Two Thousand - (\$ 2000.00 ) Dollars, payable to the order of the second party, together with interest from the date of said note on the principal sum remaining from time to time unpaid, at the rate of four & 1/2 (4 1/2) per centum per annum (or at the rate of interest fixed by Act of Congress), the first payment on interest being due and payable on the First day of November, 1949, and thereafter interest being due and payable annually; said principal sum being due and payable in twenty (20) equal, successive, annual installments of One Hundred - (\$ 100.00 ) Dollars each, and a final installment of - (\$ - ) Dollars, the first installment of said principal being due and payable on the First day of November, 1949, and thereafter the remaining installments of principal being due and payable - annually until the entire principal sum and interest are paid in full, and each installment of principal and interest bearing interest from due date until paid at the highest rate authorized to be charged under the Federal Farm Loan Act, as amended; all of which and such other terms, conditions and agreements as are contained in the said note, will more fully appear by reference thereto.

NOW, KNOW ALL MEN, that first party, in consideration of the debt as evidenced by the said note, and for better securing the payment thereof to second party, according to the terms of the said note, and the performance of the conditions and covenants herein contained, and also in consideration of the sum of One Dollar to first party in hand well and truly paid by second party, at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, in fee simple, and by these presents does grant, bargain, sell, and release, in fee simple, unto second party, its successors and assigns, the following described lands, to wit:

All that piece, parcel and lot of land lying and being in Austin Township, Greenville County, South Carolina, containing Seventy Five (75) acres, more or less, and being bounded on the North by Pierce Hughes, Clyde Boiter, formerly John W. Holland; on the East by Paul Jones, formerly Pickens and Hipp; on the South by Clyde Boiter; and on the West by the James Miller lands, formerly Hipps, all of which is specifically shown by courses and distances, metes and bounds on plat made by C. A. Adams, Surveyor, dated March, 1917, copy being recorded in Greenville County in Plat Book 25, Page 41. It is the same land conveyed to T. J. Johnson and Mittie B. Johnson by E. M. Goodnough by deed dated June 1, 1945 and recorded in Deed Book 276, Page 141.

Notwithstanding any provision herein, or in the note secured hereon, to the contrary, first party may make at any time advance payments on principal in any amount. Advance principal payments made within five years from the date hereof may be applied, at the option of second party, in the same manner as these payments are five years from the date hereof.

The debt secured by the within Mortgage having been paid in full, said mortgage is hereby satisfied and the lien thereon discharged, this the 10th day of September, 1958
