with interest thereon from date at the rate of Five with interest thereon from date at the rate of Five per centum per annum, said principal and interest to be repaid: \$100.00 on Principal on the 22nd day of April, 1949, and a like payment of \$100.00 on principal quarterly thereafter until 5 years from date at which time the entire unpaid balance will be due and payable. With the right to anticipate payment on any interest paying date in multiples of \$100.00. Said interest is to be computed and paid quarterly...

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Eastern side of Dover Street, near the City of Greenville, being shown as the Northern portion of lot No. 50, as shown on Plat of the Property of Edgar C. Waldrop, recorded in Plat Book "B" at Page 171, and having, according to said Plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Eastern side of Dover Street, at joint from corner of lots Nos. 50 and 51, and running thence with line of lot No. 51, N. 86-04 E. 150 feet to iron pin in rear line of lot No. 48; thence with line of lot No. 48, S. 3-56 E. 35 feet to iron pin at corner of property of A. M. Bridges; thence in a Southwesterly direction through lot No. 50 to iron pin on Eastern side of Dover Street; thence with the Eastern side of Dover Street, N. 3-56 W. 42 feet to the point of beginning."
