WHEREAS, the Mortgagor is well and truly indebted unto

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina: in Cantt Township, being known and designated as

Lot No. 88, according to plat of property of Woodfields, Inc., a subdivision located on the southwest side of the Augusta Road, said lot having the following metes and bounds as shown on plat made by Dalton & Neves, Engineers, recorded in the R. M. C. Office for Greenville County in Plat Book S, Page 113:

beginning at an iron pin on the southern side of Brook Forest Drive at the joint front corner of Lots 85 and 86 and running thence along the line of Lot 85 S. 35-20 W. 160 feet to an iron pin at the rear corner of Lot 85; thence N. 51-40 W. 90 feet to an iron pin at the rear corner of Lot 87; thence along the line of Lot 87 S. 35-20 E. 160 feet to an iron pin on Brook Forest Drive; thence along Brook Forest Drive S. 01-40 E. to the point of beginning.
