WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Butler Township, being known and designated as the greater portion of Lot No. 3, as shown on a Plat of the preperty of H. L. Baumgardner, prepared by W. J. Riddle, Surveyor, in February 1947, recorded in Plat Book Q at Page 197, and being more particularly described according to said Plat as follows:

"BEGINNING at a point in the Lowndes Hill Road, joint front corner of Lots Nos. 3 and 4, and running thence with the joint line of said lets, S. 1-15 E. 305 feet to a point in a branch; thence up the meanders of said branch, W. 61-30 E. 151.7 feet to a point in line of Lot No. 2; thence along line of said let, W. 16-22 W. 176.9 feet, more or less, to a point in the center of the driveway, as shown on said Plat; thence along the center of said driveway in a Northwesterly direction to a point in Lowndes Hill Road on the front line of said let; thence along said road, S. 83-45 W. 85 feet to the beginning corner."
