of each year thereafter the sum of \$23.49, to be applied on the
interest and principal of said note, said payments to continue up to and including the first day of March
1953, and the balance of said principal and interest to be due and payable on the first day of March
1953; the aforesaid monthly payments of \$ 23.49 each are to be applied first to
interest at the rate ofsix (%) per centum per annum on the principal sum of \$1,000.00 or
so much thereof as shall, from time to time, remain unpaid and the balance of each monthly payment shall be applied on account of principal.

Furman, Jr., Engineer, May 25, 1931, the following metes and bounds, courses and distances, to-wit:-
