"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northwest side of Crystal Avenue, in that area recently annexed to the City of Greenville, being shown as Lot #4 on plat of property of M. W. Jones and Crystal Alton Williams, made by R. E. Dalton, Engineer, April 1923, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwest side of Crystal Avenue at joint front corner of Lots 4 and 5, said pin being 340 feet in a Northeasterly direction from the point where the Northwest side of Crystal Avenue intersects with the East side of Old Augusta Road, and running thence along the line of Lot 5 N. 29-18 W. 200 feet to iron pin; thence N. 60-42 E. 75 feet to iron pin; thence along the line of Lot 3 S. 29-18 E. 200 feet to iron pin on the Northwest side of Crystal Avenue; thence along Northwest side of Crystal Avenue S. 60-42 W. 75 feet to the beginning corner.
