"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, about **three miles Northwest from Greer**, in the **Fairview Church** community, and containing **Twenty-eight (28) Acres**, more or less, bounded by lands now or formerly belonging to **R.B. Mason, Lee Smith** and others, and having the following courses and distances, to wit: Beginning at an iron pin on community road leading from Owens' store to Gilreath's Mill, Mason corner, and running thence **S. 75 E. 25.54** chains to iron pin and stone; thence **S. 2.00 W. 9.00** chains to stone; thence **N. 84.15 W. 25.66** chains to said community road; thence along said road, **N. 3.30 E. 13.18** chains to the beginning corner.
