WHEREAS, we the said L. G. Jones, H. W. Jones, F. A. Ross, J. H. Greer, H. L. Satterfield, J. D. Davis and Thomas Leonard as Deacons of Pelham Baptist Church

in and by our certain promissory note in writing of even date with these Presents, are well

and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of

Three Thousand xx (\$ 3000.00) Dollars,

with interest from the date hereof at the rate of six per cent (6 %) per annum, unpaid interest to

bear interest at the same rate, to be repaid in installments of
