TO ALL WHOM THESE PRESENTS MAY CONCERN: I, James Mason Von Hollen,

of Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina: All that parcel, piece or lot of land with the buildings and improvements thereon, situate, lying and being in the city of Greenville, county of Greenville, state of South Carolina, being known and designated as lot No. 3, Section C, of Croftstone Acres, as per plat thereof recorded in Plat Book S, at Pages 78 and 79 of the R.M.C. Office for said County. Said lot having a frontage of 78 feet on the Southerly side of Wedgewood Avenue, a depth of 219.4 feet on the West, 240 feet on the East, and 80 feet across the rear.
