All that certain piece, parcel or lot of land with the buildings and improvements thereon situate and being on the West side of Sherwood Street, in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot #11 on plat of Sherwood Court Apartments, Inc., made by Pickell and Pickell, Engineers, February 1948, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book W at page 9, and having according to said plat and a recent survey made by Pickell and Pickell, Engineers, March 10, 1949, the following metes and bounds, to wit:

Beginning at an iron pin on the West side of Sherwood Street, at the joint front corner of Lots 10 and 11, said pin being where the northwest edge of Ridgeland Avenue intersects with the west edge of Sherwood Street, and running thence along the line of Lot 10 N. 56-14 W. 162.2 feet to an iron pin; thence along the East edge of a parking and service drive N. 2-142 W. 23 feet to an iron pin; thence along the line of Lot 12, S. 38-140 E. 110 feet to an iron pin on the West side of Sherwood Street; thence along Sherwood Street S. 28-50 E. 30 feet to an iron pin; thence continuing with Sherwood Street S. 20-0 E. 57 feet to an iron pin; thence still with Sherwood Street S. 13-30 W. 30.3 feet to the beginning corner.
