SHERWOOD COURT APARTMENTS, INC., a corporation
created and existing under the laws of the State of South Carolina of
Greenville, S. C., hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

The Prudential Insurance Company of America

, a corporation
organized and existing under the laws of **the State of New Jersey**, hereinafter
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which
are incorporated herein by reference, in the principal sum of **Eleven Thousand Eight Hundred**
Dollars (\$11,800.00), with interest from date at the rate of **four** per centum
(**4** %) per annum until paid, said principal and interest being payable at the office of **The Prudential**
Insurance Company of America in **Newark, New Jersey**,
or at such other place as the holder of the note may designate in writing, in monthly installments of
Sixty-two and 30/100 Dollars (\$ **62.30**),
commencing on the first day of **April**, 19 **49**, and on the first day of each month there-
after until the principal and interest are fully paid, except that the final payment of principal and interest,
if not sooner paid, shall be due and payable on the first day of **March**, 19 **74**.

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of **Greenville**,
State of South Carolina:

All that certain piece, parcel or lot of land with the buildings
and improvements thereon, situate and being on the West side of
Sherwood Street, in the City of Greenville, County of Greenville,
State of South Carolina, being shown as Lot #14 on plat of Sherwood
Court Apartments, Inc. made by Pickell and Pickell, Engineers,
February 1948, recorded in the R. M. C. Office for Greenville County,
S. C. in Plat Book W, page 9, and having according to said plat and
a recent survey made by Pickell and Pickell, Engineers, March 10,
1949, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of Sherwood Street, at
joint front corner of Lots 12 and 14, said pin being 180.3 feet North
from the point where the Northwest edge of Ridgeland Avenue intersects
with the West edge of Sherwood Street, and running thence along the
line of Lot 12 S. 87-33 W. 129.2 feet to iron pin; thence along the
East edge of a parking and service drive N. 5-24 W. 3.6 feet to iron
pin; thence along the North edge of said parking and service drive S.
84-03 W. 20.8 feet to iron pin; thence along the East edge of said
parking and service drive N. 2-27 W. 47.7 feet to iron pin; thence
along the line of Lot 15 N. 87-33 E. 138.7 feet to iron pin on the
West side of Sherwood Street; thence along the West side of Sherwood
Street S. 12-27 E. 39.4 feet to iron pin; thence still along the West
side of Sherwood Street S. 23-43 E. 12 feet to the beginning corner.

TOGETHER with the right and privilege of using for parking cars and
other motor vehicles that parking and service drive, running along the
rear of said lot to Allen Street and to a 15-foot alley, and with the
right of ingress and egress in, over and across said strip of land
shown on the plat above mentioned as a parking and service drive, and
the 15-foot alley shown on said plat.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter
attached to or used in connection with the real estate herein described.
