WHEREAS, the Mortgagor is well and truly indebted unto

organized and existing under the laws of South Carolina, a corporation  
hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which  
are incorporated herein by reference, in the principal sum of **Twenty-six Hundred Fifty -**  
Dollars (\$ 2650.00 ), with interest from date at the rate of **four and one-half** per centum
