We, **John A. Cooper and Christine C. Cooper**, of Greenville, S. C., hereinafter called the Mortgagor, send(s) greetings:

All that piece, parcel or lot of land with the improvements thereon situate, lying and being in **Dunean Mills Village**, Greenville County, South Carolina, and being more particularly described as Lot No. **91**, Section **4**, as shown on a plat entitled "Subdivision for Dunean Mills, Greenville, S. C.", made by **Pickell & Pickell, Engineers**, Greenville, S. C., on June 7, 1948, revised June 15, 1948, and August 7, 1948, and recorded in the R. M. C. Office for Greenville County in Plat Book S, at pages 173-177, inclusive. According to said plat the within described lot is also known as No. **48** **Hutchins** Street (Avenue) and fronts thereon **52** feet.
