All that piece, parcel or lot of land with the improvements thereon situate, lying and being in **Duncan Mills Village, Greenville County, South Carolina**, and being more particularly described as **Lot No. 85, Section 1**, as shown on a plat entitled "Subdivision for Duncan Mills, Greenville, S. C.", made by **Pickell & Pickell, Engineers, Greenville, S. C.**, on June 7, 1948, revised June 15, 1948, and August 7, 1948, and recorded in the R. M. C. According to said plat the within described lot is also known as No. **70** **Duke** Street (Avenue) and fronts thereon **70.6** feet.
