WHEREAS, the Mortgagor is well and truly indebted unto

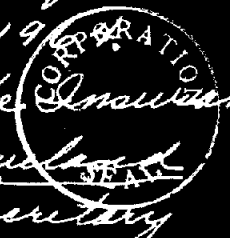
