WHEREAS, the Mortgagor is well and truly indebted unto  
LIBERTY LIFE INSURANCE COMPANY

, a corporation  
organized and existing under the laws of South Carolina, hereinafter  
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which  
are incorporated herein by reference, in the principal sum of Twenty Five Hundred Fifty---  
Dollars (\$ 2550.00 ), with interest from date at the rate of four and one-half per centum  
( 4½ %) per annum until paid, said principal and interest being payable at the office of Liberty
