(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Seventeen Hundred and No/100- - - - - DOLLARS (\$ 1700.00 ), with interest thereon from date at the rate of Six (6%) - - - per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as lot No. 3 of Section D, of Woodville Heights, recorded in Plat Book "L" at Pages 14 and 15, and replatted in Plat Book "K" at Page 272, and being more particularly described according to said plat, as follows:

"BEGINNING at an iron pin at the Northeastern intersection of Spruce Street and the Old Pickens Road, and running thence with the Said Spruce Street, N. 9-50 E. 175 feet to an iron pin in line of lot No. 4; thence with line of said lot, S. 80-10 E. 58.3 feet to an iron pin, joint rear corner of lots Nos. 2 and 3; thence with joint line of said lots, S. 9-50 W. 172.4 feet to an iron pin in the North side of the Old Pickens Road; thence with said road, N. 83-18 E. 58.3 feet to the beginning corner."
