NOW, KNOW ALL MEN, That I, the said JOHN B. GREENE

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Mortgagee all that tract or lot of land in Greenville, Township, Greenville County, State of South Carolina.

All those lots of land in Paris Mountain Township, Greenville County, State of South Carolina, near the City of Greenville, Being shown as lots Nos. 3, 4, and 5 on plat of property of T. B. Nalley, made by J. Coke Smith & Sons, in October 1947, recorded in Plat Book "S" at page 55, and described as follows:

BEGINNING at a stake at the Southeast intersection of two County Roads, and running thence with the center of a County Road, S. 85-30 E. 4.25 chains to a stake thence N. 70-45 E. 2.22 chains to a stake at corner of lot No. 2; thence with the line of said lot, S. 8-55 E. 11 chains to a stake in line of lot No. 6; thence with the line of said lot, S. 87-00 W. 3.30 chains to a stake; thence S. 85-30 W. 5.10 chains to a stake in a County Road; thence with the center of said County Road, N. 18-35 W. 3.93 chains to a stake; thence continuing with said County Road, N. 8-15 W. 7.93 chains to a stake at the intersection of another County Road; thence with the intersection of said roads, N. 51-25 E. 2.04 chains to the beginning corner.
