"BEGINNING at a point in the center of Grove Road, joint corner with lands now or formerly owned by J. B. Granger, and running thence with the center of Grove Road 404 feet to point in center of said road; thence N. 88 E. 1688 feet to iron pin; thence N. 24-20 W. 700 feet to point in center of another road; thence with the center of the last mentioned road, N. 79-10 W. 60.6 feet to iron pin; thence S. 28-20 E. 131.8 feet to stake; thence S. 84 W. 1340 feet to point in center of Grove Road; thence with said Road, S. 24-17 W. 47 feet to the beginning corner."
