in the full and just sum of One Thousand & No/100 (\$1,000.00) - - - - - Dollars, in and by my certain promissory note in writing of even date herewith, due and payable \$25.00 on the 5th day of each month commencing May 5, 1949 with the privilege to pay \$50.00 per month; payments to be applied first to interest, balance to principal. Balance due five years from date with the privilege to anticipate part or all after one year,

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near the City of Greenville, known and designated as Lot No. 18 on plat of property of Harry H. Palm according to plat recorded in Plat Book B, Page 84, in R. M. C. Office for Greenville County and having according to said plat the following metes and bounds;

BEGINNING at a point on the West side of Poplar Street, joint front corner of Lots 17 and 18, and running thence along line of Lot 17, N. 67-15 W. 190 feet to an iron pin; thence continuing along the same course a distance of six feet to the center of the branch as shown on said plat; thence along the said branch a distance of 100.9 feet; thence S. 67-15 E. seven feet to an iron pin; thence S. 67-15 E. 153 feet to a point on the West side of Poplar Street; thence along the West side of Poplar Street, N. 11-30 E. 87.6 feet to beginning.
