We, **Horace A. Fisher and Elva R. Fisher**, of Greenville, S. C., hereinafter called the Mortgagor, send(s) greetings:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of **Greenville**, State of South Carolina:

All that piece, parcel or lot of land with the improvements thereon situate lying and being in **Duncan Mills Village, Greenville County, South Carolina**, and being more particularly described as **Lot No. 89, Section 2** as shown on a plat entitled "Subdivision for Duncan Mills, Greenville, S. C.", made by **Pickell & Pickell, Engineers, Greenville, S. C.**, on **June 7, 1948**, revised **June 15, 1948**, and **August 7, 1948**, and recorded in the **R. M. C. Office for Greenville County** in **Plat Book S, at pages 173-177, inclusive**. According to said plat the within described lot is also known as No. **41 Duke** Street (Avenue) and fronts thereon **83** feet.
