I, R. LEONARD CARROLL, of Greenville, S. C., hereinafter called the Mortgagor, send(s) greetings:

All that piece, parcel or lot of land with the improvements thereon situate, lying and being in **Duncan Mills Village, Greenville County, South Carolina**, and being more particularly described as **Lot No. 56, Section 3**, as shown on a plat entitled "Subdivision for Duncan Mills, Greenville, S. C.", made by **Pickell & Pickell, Engineers, Greenville, S. C.**, on **June 7, 1948**, revised **June 15, 1948**, and **August 7, 1948**, and recorded in the **R. M. C.
