We, S. T. Walden and Stella E. Walden, of  
Greenville, S. C. , hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto  
LIBERTY LIFE INSURANCE COMPANY

organized and existing under the laws of South Carolina , a corporation  
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which  
are incorporated herein by reference, in the principal sum of Thirty-Two Hundred Fifty  
Dollars (\$ 3250.00 ), with interest from date at the rate of four and one-half per centum  
( 4½ %) per annum until paid, said principal and interest being payable at the office of Liberty

securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three  
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling  
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,  
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its  
successors and assigns, the following-described real estate situated in the County of Greenville ,  
State of South Carolina:

All that piece, parcel or lot of land with the improvements thereon situate,  
lying and being in Dunean Mills Village, Greenville County, South Carolina, and  
being more particularly described as Lot No. 13, Section 3, as shown on a plat  
entitled "Subdivision for Dunean Mills, Greenville, S. C.", made by Pickell &  
Pickell, Engineers, Greenville, S. C., on June 7, 1948, revised June 15, 1948, and  
August 7, 1948, and recorded in the R. M. C. Office for Greenville County in  
Plat Book S, at pages 173-177, inclusive. According to said plat the within  
described lot is also known as No. 25 Wallace Street (Avenue)  
and fronts thereon 80 feet.
