All that certain piece, parcel, or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, School District 7-1 (now within the corporate limits of the City of Greenville), being known and designated as Lot No. 9 of a subdivision of the property of Rachel J. Cely, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book M, at page 45, and having the following described bounds, to-wit:

BEGINNING at an iron pin on the North side of Virnell Street at the corner of Lot No. 8, which point is 240 feet N. E. of the intersection of Celand Street, and running thence along the line of Lot No. 8, N. 36-05 W. 174.5 feet to an iron pin in the rear line of Lot No. 2; thence N. 54-03 E. 80 feet to an iron pin at the rear corner of Lot No. 10; thence along the line of that lot, S. 36-05 W. 174.5 feet to an iron pin at the corner of said lot on the North side of Virnell Street; thence along the line of said Virnell Street, S. 54-03 W. 80 feet to the beginning corner.
