All that certain tract of land in Highland Township, Greenville County, State of South Carolina, on Neals Fork of South Tyger River, and bounded by lands of H. W. Barton, Blackwell and the John McKinney place, and having the following metes and bounds:

BEGINNING at an iron pin in middle of Old State Road at Blackwell's line, thence S. 41-05 E. 250 feet to an iron pin in gully, thence N. 81-56 E. 1008 feet to iron pin on top of hill; thence N. 57-17 E. 697 feet to center of creek; thence N. 18-40 W. 246 feet up said creek; thence N. 58-24 W. 156 feet up said creek; thence N. 20-12 W. 111 feet to mouth of ditch in said creek; thence S. 76-30 W. 882 feet to iron pin at edge of field; thence N. 86-30 W. 615 feet to iron pin in middle of road; thence S. 1-30 W. 588.9 feet to beginning corner, containing 25.20 acres, more or less.
