All that tract or lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as Lot No. 5, according to Plat of property of North Park, recorded in Plat Book "K", Pages 48 and 49, R. M. C. Office for Greenville County, and being more particularly described according to said Plat as follows:
