NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, situate, lying and being on the Northern side of West Park Avenue, in Ward-One of the City of Greenville, and having the following metes and bounds, according to plat made by C. M. Furman, Fr., in July, 1922, and described as follows:

\*\*BEGINNING at a stake on the Northern side of West Park Avenue, 133 feet in an Easterly direction from the intersection of West Park Avenue and Townes Street, and running thence S. 77-00 E. 90 feet to stake on Western side of a 22 foot alley; thence with said alley, N. 13-00 E. 72 feet to stake; thence N. 77-0 W. 90 feet to stake; thence S. 13-00 W. 72 feet to stake on Northern side of West Park Avenue, point of beginning.\*\*
