Office for Greenville County in Plat Book E, Page 235, being located on the eastern side of Third Avenue (formerly Judson Road) at a point 93.9 feet north of the northeastern corner of the intersection of Third Avenue and Judson Road, which point is also 10.8 feet South of the joint corner of Lots Nos. 13 and 14 and running thence along the east side of Third Avenue N. 6-08 E. 35.8 feet to an iron pin; thence S. 73-04 E. 72 feet to an iron pin; thence S. 63-31 E. 38.1 foot to an iron pin in the line of Lot No. 15; thence along the line of Lot No. 15 S. 33-29 W. 30.1 feet to an iron pin which point is 9.2 feet north of the joint rear corner of Lots Nos. 13 and 14; thence crossing the dividing line between Lots Nos. 13 and 14 N. 73-05 W. 94.2 feet to the beginning corner, and being the same property conveyed to B.
