All those certain pieces, parcels or lots of land situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, on the Northern side of Bob Thite Lane in a subdivision known as Super Highway Home Sites, being known and designated as Lots 138 and 139 of the aforementioned subdivision and being described according to a plat of Super Highway Home Sites, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book "P" at Page 53 and, according to a more recent plat prepared by J. L. Hunter, Surveyor, entitled "Property of M. G. & Ottis G. McIntyre, near Greenville, S. C.", and having, according to said plats, the following metes and bounds, courses and distances, to-wit:

which iron pin is at the joint front corner of Lots 139 and 140 and 163 feet from the intersection of Donnon Road and Bob White Lane and Funning thence along the common line of Lots 139 and 140 N. 10-10 W. 160.8 feet to an iron pin in the center of a five-foot strip reserved for utilities; thence along the center of said five-foot strip N. 46-11 E. 42.6 feet to an iron pin, the joint corner of Lots 139 and 141; thence along the common line of Lots 139 and 141 S. 70-37 E. 45 feet to an iron pin, which iron pin designates the joint rear corner of Lots 138 and 139; thence continuing in the same direction (S. 70-37 E.) along the common line of Lots 138 and 141 89.4 feet to an iron pin, the joint corner of Lots 137, 138 and 141; thence along the common line of Lots 137 and 138 S. 14-03 E. 110 feet to an iron pin on the Northern side of Bob White Lane; thence along the Northern side of Bob White Lane S.74-40 W.30 feet to an iron pin, the joint front corner of Lots 138 and 139; thence continuing along the Northern side of Bob White Lane S.79-06 W.80 feet to an iron pin, the beginning corner.
