"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon; situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Southern side of Potomac Avenue, in the City of Greenville, being shown as lot No. 235 on a plat of Pleasant Valley, made by Dalton & Neves in April 1946, with the revisions through November 1948, recorded in Plat Book "P" at Page 93, and described as follows:
