I, James Allen Staton

SEND GREETING:

I the said James Allen Staton

execute promissory note in writing of even date with these Presents, well

to the Citizens Building and Loan Association, Greer, S. C., in the full and just sum of

Three Hundred----- (\$ 300.00) Dollars,

to be paid hereof at the rate of seven per cent (7 %) per annum, unpaid interest to

be repaid in installments of

Four & 80/100----- (\$ 4.80) dollars

on the 5th day of each and every calendar month hereafter until the full principal sum, with interest and expense incurred in connection with said loan, has been paid, said monthly payments to be applied first to the payment of interest, and then to payment of principal, costs, expenses and insurance, if any, and further providing that if at any time any portion of the principal or interest due hereunder shall not be paid for a period of sixty (60) days, or upon failure to comply with any of the by-laws of the said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall at once become immediately due and payable, and said note further providing for a reasonable amount of costs and expenses of collection, to be added to the amount due on said note, and collectible thereon, the same be placed with an attorney for collection, or if said debt, or any part thereof, be collected by legal proceedings of any kind.

ALL MEN BY THESE PRESENTS, That I the said

James Allen Staton, in consideration of the said debt and sums of money

and for the better securing the payment thereof to the said CITIZENS BUILDING & LOAN ASSOCIATION, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to me the said mortgagor in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, S. C., about one -fourth mile southeast from the Town of Greer, being known as Lot. # 13, on a plat prepared for the I. M. Wood Estate, by H. S. Brockman, Surveyor of Greer, said plat dated March 20, 1946, and said property having the following metes and bounds to wit:

BEGINNING at an iron pin at the corner of Campbell and Unnamed Streets and running North 88-27 W. 55 feet to a stake at the corner of Lot. # 12 of said plat, thence N. 1-33 E. 226 feet to a stake at corner of line of Lot # 14, of said plat, thence S. 71-27 E. 129.9 feet to a stake on line of Unnamed Street, thence S. 21-41 W. 201 feet to stake at corner of intersection of Campbell Street and Unnamed Street, the beginning corner. This is the same tract and lot of land conveyed to me by E. Inman, Master, County aforesaid.
